### 30 Irish Citizens died in Southeast Asia during the Viet Nam War

During the 1960s and 70s, thousands of Irishmen and Irish women came to the U.S.A. on work visas. During the Viet Nam war, many Irishmen were drafted into military service and others volunteered. As a result thousands of Irishmen and Irish women served with honor in our military during the conflict. The Irish Viet Nam Veterans Memorial Project is an effort to recognize their service and to commemorate the 28 Irishmen and one Irish woman killed in action during the war. In County Clare, the Ennis town council voted unanimously to provide a significant piece of property for In September 2013 the memorial. Ennis town council tendered a request for design proposals. Sixteen competed. Irish artisans The winning design -- 'Reflections\_ -was selected earlier this year (see www.IVNVMP.org). It features a bronze statue of an Irish father staring into a circular infinity pool in front of three granite columns featuring the 30 names (including one Irish woman) of the fallen. The Ennis town council set November 11, 2014 as dedication date.

Donations have not met expectations and the project may be delayed, or worse. The Irish Viet Nam Veterans Project registered 501c. Memorial (3) organization; therefore, donations are legitimate tax deductions. This project is endorsed by the Virginia AOH State Board, the Vietnam Veterans of America, the Embassy of Ireland, and many other Irish/Irish-American organizations. # ~~~THE "BACK STORY" ON GERRY ADAMS' RECENT ARREST~~~

Wall Street Journal, May 4 2014: 65-year-old Gerry Adams was detained after he voluntarily presented himself at Antrim police station on 30 April. The detention of Mr. Adams had come just weeks before local and European Parliament elections, in which the Sinn Féin party hopes to make substantial electoral gains, particularly in the Republic of Ireland. Sinn Féin will continue to insist that the police have shown "double standards" in not bringing prosecutions in their investigations into

killings by British troops during the Troubles.

<u>Daily Mail</u>, 14 Aug **2012**: Americans should be concerned that a British police force, not Parliament or the Prime Minister, but the 'P.S.N.I.\_ (Police Service of Northern Ireland), an offspring of the R.U.C. (Royal Ulster Constabulary) thugs of the past, have requested of U.S. Attorney General (Eric) Holder a subpoena for

Boston College to surrender records and oral recordings.

*Irish Echo*, 10 Sep **2012**: The Ancient Order of Hibernians, Brehon Law Society and Irish American Unity Conference `have appealed to (Boston College) President William P. Leahy S.J. to join the educational

campaign regarding Britain's unprecedented effort in America to intimidate journalistic inquiry, academic freedom and to color the historical record of the Anglo-Irish conflict to their liking.

<u>The Hill</u>, 2 June 2013: In this case, the British Government, with the acquiescence of US Attorney General Eric Holder, sought interviews that IRA combatants contributed to the 'Belfast Project\_ and held at Boston College under the strictest conditions of security and confidentiality. The Obama administration agreed, sparking outcry from First Amendment advocates. Sean Hughes,

a spokesman for the Ancient Order of Hibernians in America said `We believe that these materials should be kept sacrosanct, and that their disclosure threatens to swing a wrecking ball through a painstakingly-constructed Irish Peace Process that Americans, as well as Irishmen, can rightly view with the pride of ownership.

Boston Globe, 6 May 2014: Seeking to free itself from a roiling dispute across the Boston College announced Atlantic, Tuesday ù it would release the original recordings to any of the participants who request them, a step that could help shield the people interviewed from authorities investigating past crimes in Northern Ireland. The university also said it will not retain copies or transcripts of interviews, and will continue to shield the identities of participants until their deaths. Several participants have already filed requests. Between 2001 to 2006, researchers recorded confidential interviews with members of militia groups that clashed during the conflict, under the assurance that their statements would be kept confidential until their deathsù at the urging of British authorities, the Justice Department demanded that Boston College hand over the interviews to US authorities, under an international treaty requiring the disclosure of evidence of violent crimes. After a highstakes legal battle that concluded last year, the university was forced to release portions of interviews with seven former members of the Irish Republican Army.

#### FACTOID -- ORIGINS OF THE ORDER

In 1565 Thomas Radcliffe, the Englishman appointed Lord-Lieutenant of Ireland, published an edict that prohibited all monks and Catholic priests from eating or sleeping in Dublin. Further, he ordered the head of each family to attend Protestant services every Sunday, under the penalty of a fine. Irish prince Rory O'Moore of Leix (County Laois) responded by organizing the 'Defenders\_ to protect priests and religious freedom. The Defenders enabled priests to celebrate Mass wherever possible -- often in the fields and forests. The Ancient Order of Hibernians can trace its motto "Friendship, Unity, and Christian Charity" to the Defenders. Our name came a little later  $\bar{\ }$  1641.

## TRIVIA FOR THE WELL ROUNDED HIBERNIAN

In George Washington's days, there were no cameras. One's image was either sculpted or painted. Some paintings of George Washington showed him standing behind a desk with one arm behind his back while others showed both legs and both arms. Prices charged by painters were not based on how many people were to be painted, but by how many limbs were to be painted. Arms and legs are 'limbs,' therefore painting them would cost the buyer more. Hence the expression, ''Okay, but it'll cost you an arm and a leg.\_ (Artists know hands and arms are more difficult to paint)
